Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s)

Ch.12 App.7 Art.1.8 - Causing a collision

Brief Details:

A report was received of contact between Cars 47 (Presley Barrett) and Cars 88 (Barry Holmes) and 27 (Martin Wijetunga) at Taylors Hairpin (Post 9a), resulting in Car 88 spinning and race-ending damage for Car 27. Following investigation by Assistant Clerk of the Course, Richard Crozier, it was found that Car 47 locked up their brakes / ABS'd upon initiating an overtaking move on Car 27, overshooting Car 27 and colliding with the right-rear of Car 88, spinning 88 around. The front-left of Car 27 then collided with the right-rear of the slow-travelling Car 47, resulting in terminal front-left damage for Car 27. Having examined the available evidence and representations from the drivers of Cars 47 and 88, and the entrant of 88 (Malcolm McNab), the driver of Car 47 (Presley Barrett) was found to be wholly responsible for causing a collision - in accordance with 2026 Scottish MINI Cooper Cup Championship Sporting Regulations Art 4.3 Table of Penalties, this carries with it the addition of 30 seconds added to race time, and 3 penalty points added to the driver's competition licence.

Evidence Relied Upon:

Representations from driver of Car 47 (Presley Barrett), driver of Car 88 (Paul Holmes), entrant of Car 88 (Malcolm McNab), circuit CCTV footage, and onboard footage from Cars 47 and 88 (both front facing).

Accordingly, under NCR Ch.5A App.5 Art.2, I hereby order that you receive the following:

Addition of 30 seconds to your race time
Number of Licence Penalty Points: **3**

You are reminded of your right of appeal.
